AMY WALTER | KEYNOTE SPEAKER

Publisher and Editor-in-Chief of the Cook Political Report with Amy Walter and Popular On-Air Political Analyst

For more than 25 years, Amy Walter has built a reputation as an accurate, objective, and insightful political analyst with unparalleled access to campaign insiders and decision-makers. Known as one of the best political journalists covering Washington, she is the publisher and editor-in-chief of the non-partisan *Cook Political Report with Amy Walter*, where she provides analysis of the issues, trends, and events that shape the political environment. A contributor to the PBS NewsHour, she provides weekly political analysis for the popular "Politics Monday" segment and is a featured contributor for the network's election and convention special coverage events. She is also a regular Sunday panelist on NBC's *Meet the Press* and CNN's *Inside Politics*, and appears frequently on *Special Report with Bret Baier* on Fox News Channel. From 2017 until early 2021, Walter was the host of the weekly nationally syndicated program "Politics with Amy Walter" on *The Takeaway* from WNYC and PRX. She's also the former political director of ABC News.

In her presentations, Walter expertly breaks down the electoral process, congressional culture, and the Washington political scene. Her astuteness, wit, and range of expertise creates an engaging, compelling presentation, and her reliable and accurate analysis has earned her numerous accolades. Exclusively represented by <u>Leading Authorities</u> <u>speakers bureau</u>, Amy Walter takes audiences on an insider's tour of Washington through the eyes of the woman with her finger on the pulse of politics.

Political History. Before ABC, she was the editor-in-chief of *The Hotline*, Washington's premier daily briefing on American politics. There she served as the political publication's primary voice for three years, and she provided regular analysis of the national political environment in her weekly National Journal column, On the Trail. Walter has provided election night coverage and analysis since 1998 and was a member of CNN's Emmy-award winning election night team in 2006.

Accolades and Education. Named one of the "Top 50 Journalists" by *Washingtonian* magazine, as well as one of its "50 Most Powerful Women," Walter was dubbed one of the most powerful people in politics in *George* magazine for her insights into the mechanics that make the political machine run. She also won the Washington Post's Crystal Ball Award for her spot-on election predictions and has been frequently quoted as a congressional election expert in newspapers such as the *Wall Street Journal*, *Washington Post*, and the *New York Times*. Charlie Cook, *Cook Political Report* founder and contributor and political analyst for National Journal and NBC News, said, "Today, her work is trusted and respected by Democrats and Republicans alike. She knows how to get beyond bluster and spin to unearth — and explain — what really matters in a political arena. And, she has a proven track record of success, which is essential for those whose jobs depend on accurate political forecasting."

Walter graduated summa cum laude from Colby College. She was also honored by her alma mater her with an honorary PhD, and now serves on the Board of Advisors. She is also a member of the Board of Advisors for the University of Chicago's Institute of Politics, where she was an inaugural fellow.



UNITED STATES SENATOR BILL HAGERTY(R-TN) CONGRESSIONAL ADDRESS

United States Senator Bill Hagerty was elected to the U.S. Senate in 2020 and is currently serving his first term representing the state of Tennessee. His committee assignments include: U.S. Senate Committee on Banking, Housing, & Urban Affairs; U.S. Senate Committee on Foreign Relations; U.S. Senate Committee on Appropriations; and the U.S. Senate Committee on Rules & Administration. Prior to his election to the U.S. Senate, Hagerty served as the U.S. Ambassador to Japan, the world's third largest economy and America's closest ally in the region.

Hagerty is a life-long businessman. He started his business career with the Boston Consulting Group, where his work took him to five continents, including three years based in Tokyo, Japan. He later became a venture capital and private equity investor where he invested in and served as an executive and board member of a wide range of companies, including ones listed on the New York Stock Exchange and NASDAQ. From 2011 to 2014, Hagerty took leave from his business career to serve as a member of the Governor's Cabinet and Commissioner of the Tennessee Department of Economic and Community Development. During his tenure as commissioner, Hagerty reorganized the department, eliminating over 40 percent of the positions and saving millions of taxpayer dollars. At the same time, the new approach helped spur the strongest economic transformation seen — taking Tennessee from an unemployment rate higher than the national average when he arrived to become the number one state in the nation for jobs created through foreign investment and being named State of the Year for Economic Development an unprecedented two years in a row during his tenure.

Hagerty, an Eagle Scout, is originally from Sumner County, Tennessee. Today, he and his wife Chrissy are both active volunteers in several community and civic organizations, and live in Davidson County, Tennessee. They are the parents of four children.



UNITED STATES SENATOR MARSHA BLACKBURN (R-TN) CONGRESSIONAL ADDRESS

U.S. Senator Marsha Blackburn was sworn in to the Senate in January 2019.

Marsha Blackburn was elected to the U.S. Senate in 2018, and is currently serving her first term representing the state of Tennessee. Before her election to the Senate, Marsha represented Tennessee's 7th Congressional District. Blackburn's public service is dedicated to promoting opportunities for women and making America a more prosperous place to live. Blackburn's leadership philosophy is based on her experiences in the private sector as a small businesswoman and author, as well as being a mother and grandmother.

Blackburn went to college on a 4-H scholarship and worked her way through school selling books for the Southwestern Company as one of their first female sales associates, and later as one of their first female sales managers. She then became Director of Retail Fashion and Special Events for the Castner Knott Company, which was a Nashville-based regional department store. Later, Blackburn founded her own business, Marketing Strategies, which focused on the retail marketplace, as well as electronic and print media.

Blackburn began her career in public service in 1995 when she was named executive director of the Tennessee Film, Entertainment, and Music Commission. In 1998, she was elected to the Tennessee State Senate. In the state legislature, she earned a reputation for fiscal responsibility and government accountability by identifying waste and offering realistic solutions to Tennessee's budget challenges.

While serving in the Tennessee Senate, Blackburn led a statewide grassroots campaign to defeat a proposed state income tax. The tax was defeated, and Blackburn's leadership earned her a reputation as an anti-tax champion. In 2014, the people of Tennessee passed an amendment to the state constitution to expressly prohibit a state income tax – a fitting cap to a 14-year battle.

In 2002, Blackburn was elected to represent the people of Tennessee's 7th Congressional District based on her record in the state legislature. She brought her Tennessee values to Washington, DC, and became a leader in the fight for small, efficient federal government that is accountable to its citizens. As a Congressman, Blackburn was often selected by her colleagues to lead the charge for principled conservativism. Her congressional career was also noted for her Chairmanship of the Energy and Commerce Committee's Subcommittee on Communications and Technology, as well as bipartisan expertise in defending songwriters' and performers' rights.

Blackburn is a member of numerous charitable organizations and is an active member of her church, Christ Presbyterian. Blackburn and her husband Chuck live in Williamson County, Tennessee. They have two children, Mary Morgan (Paul) Ketchel and Chad (Hillary) Blackburn, three grandsons, and a granddaughter. Originally from Laurel, Mississippi, Blackburn is a graduate of Mississippi State University.

Dr. Kang is a psychologist and the Chief Quality Officer, Inpatient Services, for Acadia Healthcare where he leads all quality functions in support of best-practice delivery in patient safety, patient experience, regulatory preparedness, accreditation readiness, and the use of clinical outcomes to improve patient care and third-party stakeholder engagement.

Prior to joining Acadia, Dr. Kang served as the Chief Clinical Officer for BrightView Health, a private-equitybacked substance use disorder treatment organization, where he led the development, implementation, and research of best practices in addiction treatment, along with BrightView's contributions to the evolving national standard of quality and value in addiction medicine. Prior to his role at BrightView, Dr. Kang led behavioral health program design, strategy, and innovation across the care continuum for Bon Secours Mercy Health, the largest health system in Ohio.

Dr. Kang was selected by President and Mrs. Obama for the Obama Foundation's inaugural Fellowship class for his leadership in treating addiction collaboratively with partners across the healthcare system. In addition to serving on the National Quality Forum's Technical Expert Panel on Opioid Use and Opioid Use Disorder and being appointed by Ohio Governor Mike DeWine to two four-year terms on the RecoveryOhio Advisory Council, he is the second-ever non-physician to be appointed to the American Society of Addiction Medicine's Quality Improvement Council. Dr. Kang is also a prolific writer and media presence. His editorial pieces on addiction treatment services, policy, and science have been featured by the *Huffington Post UK*, London School of Economics, *The Hill*, local news outlets across the country, and he is a co-editor of the forthcoming 4th Edition of *The ASAM Criteria*. Winner of ASAM's 2021 Media Award, he also makes regular live television appearances to educate the public on behavioral health and wellness and has been featured on *PBS Newshour*.

David Dill is chairman and chief executive officer of Lifepoint Health. In this role, he is responsible for the development and oversight of Lifepoint's strategic priorities and organizational growth, advancing the company's mission and strengthening its culture enterprise-wide. He joined Lifepoint in 2007 as Executive Vice President and Chief Financial Officer before serving in his most recent role as President and Chief Operating officer from 2009 to 2018. Under his leadership, the company has expanded its footprint to 87 hospital campuses, with revenue growing from \$3 billion in 2009 to more than \$8 billion in 2018 and enhanced its focus on quality and patient safety.

Before joining Lifepoint, David was Executive Vice President of Fresenius Medical Care North America and chief executive officer in the East Division of Fresenius Medical Care Services, a wholly owned subsidiary of Fresenius Medical Care AG & Co. KGaA.

David is a former chairman of the board for the Federation of American Hospitals (FAH) and currently serves as a member of the FAH's board and Executive Committee. He also serves on the American Hospital Association's Health Systems Committee. He is immediate past chair of the board of directors for the Nashville Health Care Council and remains an active board member. Additionally, he serves as a director on the boards of R1 RCM and the American Heart Association's Greater Southeast Affiliate and is a member of the board of trustees for the Murray State University Foundation.

John Riggi, having spent nearly 30 years as a highly decorated veteran of the FBI, serves as the first national advisor for cybersecurity and risk for the American Hospital Association. In this role, he serves as a trusted advisor to the leadership of nation's hospitals and health systems. John is a prominent national advocate on healthcare cyber policy and legislative issues – including providing testimony and briefings to Congress which assisted in the passage of PL 116-321, which provides regulatory relief for HIPAA covered victims of cyber attacks.

In 2021, John's prominent advocacy encouraged the government to raise the investigative priority level of ransomware attacks to equal that of terrorist attacks. John works closely with healthcare victims of cyber ransomware attacks during and post attack.

While at the FBI, John served as a representative to the White House Cyber Response Group, a Senior representative to the CIA and on the NY FBI SWAT team for eight years. He is the recipient of the FBI Director's Award for Special Achievement in Counterterrorism and the CIA's George H.W. Bush Award for Excellence in Counterterrorism, the CIAs highest counterterrorism award.
